**NOTIFICATION**

**WHEREAS**, the Himachal Pradesh Deposit Refund Scheme, 2025 was notified on 16-06-2025 regarding regulating and providing a mechanism for collection of Non-Biodegradable packaging waste as per the polluters pay principle to prevent littering or disposing of Non-Biodegradable Garbage in public drains, roads and places open to public view in the State of Himachal Pradesh and ensuring proper recycling of collected waste to promote circular economy within the State of Himachal Pradesh.
